Members of Devereux received a total of 57 individual listings across 18 practice areas in Chambers UK 2015 edition. 10 members have new entries, 9 rose in ranking, whilst Colin Edelman QC and Robert Weir QC were recognised as Star Individuals.

# Clinical Negligence
