Ashley is a former chair of the Tax Law Committee of the Law Society. He was a member of its Corporation Tax Sub-Committee for 15 years and its chair for three years. He is currently a member of the committee of the British Branch of the International Fiscal Association and its representative on the committee of the European Region of the International Fiscal Association.

Recent instructions include:

- Advising a multinational group on a long-running transfer pricing enquiry including representing the client at mediation proceedings with HMRC.
- Advising on the UK tax implications for investment funds on bids to become major investors in UK infrastructure projects.
- Advising on the repayment of shareholder funding in large closely-held groups.
- Advice on the income tax treatment of profits of partnerships and LLPs, including in relation to the MMR rules.
